TSPN hosted a particularly well-attended and active Advisory Council meeting on February 8 at Goodwill Industries of Middle Tennessee in Nashville.

Marie Williams, LCSW, the newly appointed Commissioner of the Tennessee Department of Mental Health and Substance Abuse Services, addressed the approximately 70 people in attendance, introducing her leadership staff. She acknowledged the continuing work of the leaders and members of the Advisory Council, as well as Tennessee's Zero Suicide Initiative, and articulated her support for TSPN's ongoing suicide prevention efforts. She also referenced her anticipated appearance during TSPN's symposium "Steps Toward a Safer Tennessee", scheduled for April 19 in Nashville.

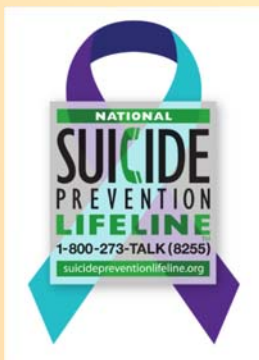
Additionally, Dr. Adele Lewis, Deputy State Chief Medical Examiner for the State of Tennessee, provided the group with information about Tennessee Medical Examiner System, including the process for referral of suspected suicides to regional forensic centers and the process for certification of death by suicide. She also discussed her office's efforts to confirm the accuracy of suicide death data reported by county medical examiners and attempts to emphasize the importance of accurate cause-of-death classification. Furthermore, she thanked the Network for its interest in assisting state and local medical examiners with addressing the needs of families who have lost loved ones to suicide.

The business meeting saw passage of the following resolutions from the Advisory Council:

- The Council approved the evaluation piece for the 2017 revision of the Tennessee Strategy for Suicide Prevention, the state plan which sets priorities for the state and regional networks.
- Ben Harrington, Executive Director of the Mental Health Association of East Tennessee, was unanimously elected to TSPN's Emeritus Group. This group recognizes Council members who have rotated off the group but are still involved with Network projects and activities, honors Council members who have provided outstanding service to TSPN and to suicide prevention efforts within our state.
- The Council approved the re-introduction of the Ken and Madge Tullis Suicide Prevention Act during the 110th General Assembly, as well as legislation related to the suicide prevention license plate.
- The Council endorsed submission of a letter to the Commissioner of the Tennessee Department of Health encouraging the state to apply for inclusion in the National Violent Death Reporting System (NVDRS). This active surveillance system initiated by the Centers for Disease Control collects data regarding violent deaths in the United States, including suicides. Data obtained from NVDRS has helped several other states develop proactive suicide prevention strategies.
- The Council established a workgroup to partner with the State Office of the Chief Medical Examiner to support its efforts and work with medical examiners to support families affected by suicide.
- The Council authorized TSPN to secure a new home for the International "Faces of Suicide" Memorial Wall to be located in Nashville (currently housed in Columbia) in order to support the wall's continued development and availability to those who have contributed to it thus far.

Guests also received an overview of the latest youth suicide data for Tennessee, updates regarding TSPN's symposium planned for April (see pages 2 and 4), and details on outreach to state licensure boards regarding suicide prevention requirements. Guests were also briefed on the next meeting of the Advisory Council, set to convene during the annual retreat at Montgomery Bell State Park in Burns on June 7-8.

“STEPS TOWARD A SAFER TENNESSEE” SET FOR APRIL 19 IN NASHVILLE

TSPN continues to take registrations for "Steps Toward a Safer Tennessee", a statewide symposium planned for Wednesday, April 19, at Trevecca Community Church, located at 335 Murfreesboro Pike in Nashville, ZIP 37210.

Our keynote speaker will be Sue Klebold, mother of one of the students involved in the Columbine High School incident. Since then, Mrs. Klebold has become a mental health and violence prevention advocate, and is the author of *A Mother's Reckoning: Living in the Aftermath of Tragedy*. (The date of the symposium is one day before the 18th anniversary of the Columbine shooting.)

“Between 2010 and 2015, 4,921 men, women, and children in the state of Tennessee have died by suicide. Meanwhile, the problem of other-directed violence has become a major concern within Tennessee and nationally. The two issues are more tightly connected than they first appear—in any given year, nearly two-thirds of the of the suicide deaths mentioned earlier, and about half of those nationally, involved firearms,” explains TSPN Executive Director Scott Ridgway. “It is our belief that educating the public, especially those who use firearms, about suicide risk and safe storage is the key to preventing future tragedies and reducing the incidence of suicide.”

“I am pleased to announce that Granger Brown, MSW, LMSW, TSPN's former Substance Abuse Outreach Coordinator, has agreed to chair this upcoming symposium and has invested financially in its success,” Ridgway added. “A retired therapist and longtime mental health advocate, it was Brown's recommendation to have a suicide prevention symposium focused on violence prevention. Granger is not only a longtime supporter of TSPN, but a truly dedicated mental health professional.”

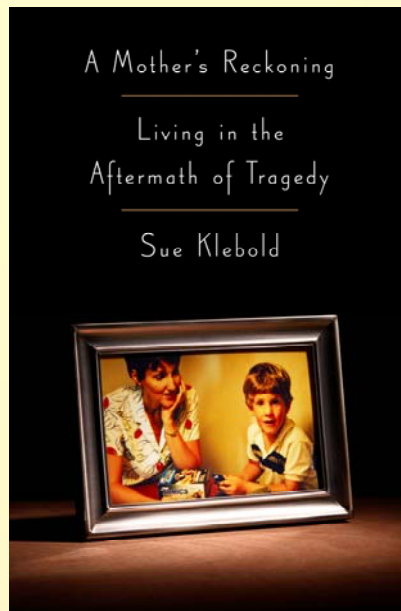
The event is expected to draw approximately 400 people, primarily healthcare professionals, mental health advocates, survivors of suicide and those with lived experience, and state department employees. TSPN ANNOUNCES PARTNERSHIP WITH CRISIS TEXT LINE

The Tennessee Suicide Prevention Network (TSPN) and Crisis Text Line, a free, 24/7 text-messaging support line for people in crisis, announce the launch of a partnership bringing crisis support to anyone in the state.

Established in 2013, Crisis Text Line provides access to a trained crisis counselor who can provide immediate support and referrals not just for suicidal thoughts, but also for anxiety, depression, child and domestic abuse, substance abuse, eating disorders, human trafficking and beyond. Users simply text "TN" to 741-741 to connect with a crisis counselor.



"Not everyone in crisis is comfortable verbalizing their problems or talking to relative strangers on the phone. Meanwhile, many teens and young adults—a high-suicide-risk population group—use their phones for texting instead of talking," explains TSPN Executive Director Scott Ridgway. "The Crisis Text Line offers an alternative means of contact for people who might not reach out for help otherwise."

As part of the partnership between TSPN and the Crisis Text Line, the latter will provide TSPN with state-specific trends in texts sent to the line. An example of these trends is available at www.crisistextline.org/trends.

"We are psyched to partner with TSPN to bring Crisis Text Line to Tennesseans in pain. Our Tennessee-specific data trends will help TSPN continue to develop policies to save even more lives," said Nancy Lublin, Founder and CEO of the Crisis Text Line.

Crisis Text Line was founded in 2013, an outgrowth of the international community action non-profit Do Something, as a resource for members in crisis. As of the end of 2016, the service has processed over 28 million text messages from users across the US. AT&T, Sprint, T-Mobile, and Verizon all waive fees for use of the service, and texts to the line do not appear on cell phone billing records.

The service is available through Facebook Messenger ([facebook.com/crisistextline](https://www.facebook.com/crisistextline)) and has a partnership with Kik, a smartphone instant messenger popular with teens, where users in crisis receive referrals to the service.

TSPN RESPONDS AFTER LOSS OF MNPD OFFICER

TSPN provided resources to the community, including an interview for WTVF, following the death of Metropolitan Nashville Police Department Officer Eric Mumaw in the line of duty on February 2.

Mumaw, an 18-year MNPD veteran, died during the water rescue of a woman who attempted to drive her car into the Cumberland River. He was subsequently honored with tributes across the state of Tennessee for making the ultimate sacrifice in trying to save the life of another. Nashville’s Metro Courthouse, the Korean War Veterans Memorial Bridge and several other buildings were lit up in blue that evening, and Nashville Mayor Megan Barry ordered all Metro buildings to fly their flags at half-staff.

Ridgway provided an interview to WTVF’s Brandon Johnson which was included on that evening’s 10 PM news broadcast. He provided information about the National Suicide Prevention Lifeline (1-800-273-TALK, or 8255) and its availability for people in crisis. Viewers were also encouraged to reach out to police and other emergency services if they or someone they knew was suicidal.

A companion article on the WTVF’s website (<http://bit.ly/2kqnwGb>) provided the Lifeline number and a listing of common suicide warning signs.

TSPN sent out a press release to all Nashville-area TV stations on the afternoon of Mumaw’s death, acknowledging his bravery and the need for the public to understand more about suicide prevention: “The public needs to be aware of the warning signs of suicide and how they can intervene to prevent suicide. In the meantime, we applaud the bravery of the officers who worked to save a life, and especially the selfless sacrifice of Officer Eric Mumaw.”

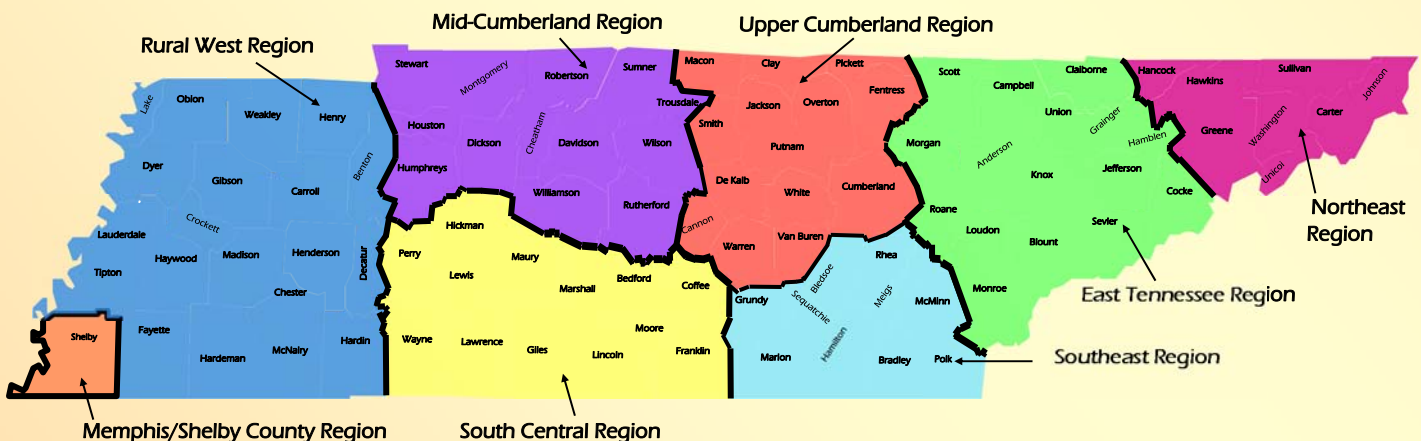
